Mayor Bouziga called this meeting to order at 7:00 P.M.

Councilman Mike Billiot presented a motion and Councilman Priscilla Mounic seconded approving the minutes from the meeting held on Monday, February 21, 2011. The Council unanimously approved the motion as presented.

Councilman Jody Cheramie led everyone in reciting the Pledge of Allegiance and a prayer.

Councilman David Adams presented a motion and Councilman Jody Cheramie seconded approving a building permit application for Benjamin and Peggy Norman be turned over to the Board of Adjustments for review. The Council unanimously approved the motion as presented.

Councilman Frank Boura presented a motion and Councilman David Adams seconded approving an Occupational License for Plaisance Oilfield Services, Inc. The Council unanimously approved the motion as presented.

Councilman Frank Boura presented a motion and Councilman Mike Billiot seconded approving to defer advertising for the sale of the 2008 Kubota. The Council unanimously approved the motion as presented.

Councilman Frank Boura presented a motion and Councilman Priscilla Mounic seconded approving advertising for part-time pool employees. The Council unanimously approved the motion as presented.

Mayor Bouziga presented correspondence from Municipal Police Employee Retirement System confirming an increase in the Town's portion of police retirement from 25% to 28% effective July 1, 2011.

Mayor Bouziga thanked the police department and field workers for a job well done during Mardi Gras.

Councilman David Adams presented a motion and Councilman Priscilla Mounic seconded approving the Mayor execute and enter into a Cooperative Endeavor Agreement with South Central Planning and Development Commission for the purpose of implementing and administering the Code Compliance Program. The Council unanimously approved the motion as presented.

Mayor Bouziga presented a slide show of repairs needed at the Pump Station. After meeting with the Lafourche Parish Drainage District on Thursday of last week, the Drainage District approved funds in the amount of \$17,000.00 to conduct the repairs.

Councilman Jody Cheramie presented a motion and Councilman Frank Boura seconded approving the 2001 Ford Expedition be advertised for sale. The Council unanimously approved the motion as presented.

Mayor Bouziga presented a spread sheet with employee salaries and benefits and also of overtime from January 1 through March 10, 2011. After a brief discussion regarding the decrease in sales tax and overtime, Councilman David Adams presented a motion and Council Mike Billiot seconded approving all overtime be cut except for the eight hours each police officer receives each pay period and pre-approved overtime. The Council unanimously approved the motion as presented.

Mayor Bouziga informed the Council damages to the siding on the DMV Building from the strong winds have been repaired.

Mayor Bouziga informed the Council culverts have been purchased to place on Dursette Street as per Councilman Boura's request. Councilman requested additional drainage work on Dursette Street near a catch basin.

Councilman David Adams presented a motion and Councilman Frank Boura seconded approving a street light be removed from Oakridge Community Park and on Preston Lane. The Council unanimously approved the motion as presented.

Mayor Bouziga presented a livestock ordinance from the Town of Lockport to be reviewed and discussed at the next Council meeting.

Mayor Bouziga requested adding a property complaint to the agenda. No audience comments were presented. Councilman David Adams presented a motion and Councilman Priscilla Mounic seconded approving Mayor Bouziga add the property complaint to the agenda. The Council unanimously approved the motion as presented.

Mayor Bouziga informed the Council a complaint was received regarding property located at 148 Pierce Street. After a brief discussion Councilman David Adams presented a motion and Councilman Priscilla Mounic seconded approving a clean-up letter be sent to the property owner of 148 Pierce Street. The Council unanimously approved the motion as presented.

Mayor Bouziga requested adding Doucet Street drainage to the agenda. No audience comments were presented. Councilman David Adams presented a motion and
