The Mayor and Council of the Town of Golden Meadow met for their regular scheduled meeting on Monday, July 18, 2011 at 7:00 P.M. at the Town Hall, 107 Jervis Drive, Golden Meadow, LA 70357.

Councilman David Adams presented a motion and Councilman Mike Billiot seconded approving minutes from meeting held on June 20, 2011. The Council unanimously approved the motion as presented.

Mayor Bouziga led everyone in reciting the Pledge of Allegiance and Councilman Jody Cheramie led everyone in prayer.

No building permits were submitted.

Laci & Ryan Latiolais property subdivision was reviewed by the Planning and Zoning Commission. The commission unanimously approved the subdivision of property. Councilman David Adams presented a motion and Councilman Mike Billiot seconded unanimously approving the subdivision of property owned by Laci and Ryan Latiolais upon the unanimous approval of the Planning and Zoning Commission. The Council unanimously approved the motion as presented.

Councilman Priscilla Mounic presented a motion and Councilman Mike Billiot seconded unanimously approving the advertisement of a Planning and Zoning Commission meeting on Monday, August 1, 2011 at 6:40 P.M. to discuss the subdivision of the Tim Callais property. The Council unanimously approved the motion as presented.

No occupational licenses were submitted.

Councilman Mike Billiot presented a motion and Councilman David Adams seconded approving Ordinance 458 amending the "No Smoking" ordinance to include a fine for smoking and prohibit smoking under the Oakridge Park Pavilion. The Council unanimously approved the motion as presented.

Mayor Bouziga informed the Council Julian Badger has removed the abandoned vehicle located at 129 Lefort Lane.

Councilman David Adams presented a motion and Councilman Priscilla Mounic seconded approving a building inspector inspect property owned by Lincoln Martin located at 115 Mrs. Thomas Pitre Lane. The Council unanimously approved the motion as presented.

Mayor Bouziga presented a slid show of the repairs being conducted on the Petit Caporal and the water lilies project being conducted in the drainage reservoir canal.

Engineer John Plaisance informed the Council that the Waterline Project in Oakridge Park is ready to begin.

Councilman Jody Cherie presented a motion and Councilman David Adams seconded approving Ridgewood Blvd. and Louviere Lane speed control device petitions be sent to Lafourche Parish for processing. The Council unanimously approved the motion as presented.

Councilman David Adams presented a motion and Councilman Priscilla Mounic seconded approving Mayor Joey Bouziga send a letter to DOTD requesting the cleaning of the drainage traps along LA 1. The Council unanimously approved the motion as presented.

Mayor Bouziga requested adding Engineer Qualifications, Sewer Phase III, Sewer Phase IV, Seawall Phase II, and Port Commission to the agenda. No audience comments were presented. Councilman David Adams presented a motion and Councilman Mike Billiot seconded approving Mayor Bouziga add to the agenda. The Council unanimously approved the motion as presented.

Engineer John Plaisance updated the Mayor and Council on the Sewer Phase II and IV Projects. Sewer Phase III Plans have a few adjustments awaiting approval and Sewer Phase IV plans are almost complete.

Engineer Plaisance informed the Council Seawall Phase II should be ready for bid at the end of August.

Mayor Bouziga informed the Council the Greater Lafourche Port Commission would like to donate an abandoned trailer to the Town. Paperwork has been forwarded to Attorney Mitch Theriot for review.

Mayor Bouziga requested audience comments.

Mr. Joseph Mickles stated he believes the Town should request a caution light be installed at the intersection of Alex Plaisance Blvd, Oakridge Drive and the Alario Bridge. After a brief discussion Councilman David Adams presented a motion and Councilman Jody Cherie seconded approving Mayor Bouziga submit a request to install a caution light as previously discussed. The Council unanimously approved the motion as presented.

The Council briefly discussed the drainage around the State Bank area.
