The Mayor and Council of the Town of Golden Meadow met for their regular re-scheduled meeting on Wednesday, September 3, 2014 at 7:00 P.M. at the Town Hall, 107 Jervis Drive, Golden Meadow, LA 70357.

Mayor Joey Bouziga called this meeting to order at 7:00 P.M.

Councilman David Adams led everyone in reciting the Pledge of Allegiance and Councilman Willis Touts led everyone in prayer.

Councilman David Adams presented a motion and Councilman Lindberg Lorraine seconded approving the minutes from the meetings held on August 18, 2014. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga informed the Council, no building permits or Occupational Licenses were submitted for approval.

Mayor Joey Bouziga presented the clean-up report as follows:
