The Mayor and Council of the Town of Golden Meadow met for their regular scheduled meeting on Monday, June 1, 2015 at 7:00 P.M. at the Town Hall, 107 Jervis Drive, Golden Meadow, LA 70357.

Mayor Joey Bouziga called this meeting to order at 7:00 P.M.

Councilman David Adams led everyone in reciting the Pledge of Allegiance and Councilman Jody Cheramie led everyone in prayer.

Councilman Willis Toups presented a motion and Councilman Priscilla Mounic seconded approving the minutes from the previous meeting held on Monday, May 18, 2015 . The Council unanimously approved the motion as presented.

Mayor Joey Bouziga presented the building permits as follows:

- Marty Rotolo – Planning and Zoning Commission meeting has been scheduled on June 15, 2015 at 6:45 P.M.
- Shane Rogers – Was hand delivered a letter informing him he needs a building permit for the two recreational vehicles located on his property. Mr. Rogers has contacted the Mayor and was given instructions on how to obtain the permits and it is unknown at this time if Mr. Rogers has applied for his permits. This will be reviewed at the next meeting.

Councilman David Adams presented a motion and Councilman Jody Cheramie seconded approving an Occupational License for NJH Enterprises, 917 North Bayou Drive, owner Nicholas Hebert. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga presented the Public Nuisance/Abandoned Vehicles report:

Engineer John Plaisance presented the project report as follows:

- North Sewer Plant Upgrades remains in the planning stage
- Sewer Phase IV continues in the right-of-way phases
- Sewer Phase V – has been funded by Community Development
- Seawall Phase I Repairs – have been completed with change order approved at last meeting
- Seawall Phase III – remains in the planning stages
- Fuel System Canopy – work continues
- Lift Station Upgrade Project – waiting for funding approval
- Skate Board Park – Spawn Ranch Consultant will contact office in the coming weeks
- Town Hall Improvements Project – work continues
- Water Enrichment Grant - was submitted for funding
- Pool Repairs – the pool should be ready for operations on Monday and repairs will continue

Mayor Bouziga presented the legal report due to Attorney Bryce Autin being absent.

- Unpaid clean-up – still progressing
- Unpaid Sewer – still progressing
- Ordinance on Digging- will present report at next meeting
- Golf Cart – will present report at next meeting

Mayor Joey Bouziga informed the Council the changes on the fine schedule have been turned over to Attorney Bryce Autin for further review.

Mayor Joey Bouziga informed the Council no bids were turned in for the two 1000 gallon fuel tanks.

Mayor Joey Bouziga informed the Council one bid was turned in for the 2002 chevy 4x4 pickup. Councilman David Adams presented a motion and Councilman Jody Chermie seconded approving to accept the bid from Southern Auto Belts in the amount of \$1326.56. The Council unanimously approved the motion as presented.

Mayor Joey Bouziga informed the Council no bids were turned in for the 43 treated piles, 90 deck boards and 185 fiberglass sheet piles. Mayor Bouziga briefly discussed with the Council that the Town could possibly use this left over material for other jobs pertaining to the seawall and will discuss this further at the next meeting.

Councilman Jody Chermie briefly asked about the drainage project on Eva Lane. Mayor Joey Bouziga said all the equipment is in place and waiting on the contractor.
