The Mayor and Council of the Town of Golden Meadow met for a Special Meeting, to discuss the conduct of a Police Officer, Tuesday, October, 11, 2016 at 6:00 P.M., at the Town Hall 107 Jervis Drive, Golden Meadow, LA 70357.

Mayor Joey Bouziga called the Special Meeting to order at 6:00 P.M.

Councilman David Adams led everyone in reciting the Pledge of Allegiance and Chief Reggie Pitre led everyone in prayer.

Mayor Joey Bouziga asked Officer Christopher Pitre if he would like to discuss this matter in executive session or regular session as documented in the letter delivered 24 hours prior to this meeting. Officer Christopher Pitre stated regular session was good.

Chief Reggie Pitre informed the Mayor and council he received a formal complaint on Officer Christopher Pitre. Asst. Chief Charles Findley investigated the complaint and found it to be a ligament complaint. Officer Christopher Pitre presented several questions to the Chief of Police and Asst.
