Mayor's Report:

Paul Pechon and Amanda Lasserre from Bourgeois and Bennett Certified Public Accountants presented the 2023 Final Audit Report for The Town of Golden Meadow, with no findings or exceptions for the 2023 year. A motion to accept the 2023 Financial Audit, as presented, was made by Council Member Plaisance; seconded by Council Member Latiolais. A roll call vote took place as follows: YEAS: Cheramie, Plaisance, Toups, Latiolais, Billiot. NAYS: NONE; ABSTAINED: NONE; ABSENT: NONE.

Mayor Bouziga advised that about 40 feet of generator wires were stolen from the Pump Station and that Chief Troy Dufrene is reviewing the cameras.

Mayor Bouziga also advised that a new plant was stolen by the Welcome Sign on the north side of the Corporation.

Mayor Bouziga advised that Town Engineer John Plaisance could not make the meeting. The North Sewer Treatment Plant Upgrades are still a work in progress and the deadline to complete was 5/31/2024. Town Clerk Tracee Cloutier advised that Town Engineer Plaisance advised they will need additional days to complete due to rain delays and it should be finished before 6/17/2024.

Due to the absence of Town Engineer Plaisance, a motion to defer Project Status Report-Items 2 through 9 to the 6/17/2024 meeting, as presented, was made by Council Member Plaisance; seconded by Council Member Cheramie. Town Attorney Jeray Jarreau presented the Attorney's Report:

- 1504 S. Bayou Dr. (Walter Guidry Jr. and Martin Perkins)-Condemnation Order issued for Owner to repair or demolish the property by 6/3/2024. SCPDC's Building Inspector Joseph Cehan stated that he had a walk through with Mr. Guidry on 5/28/2024 and based off of that and the engineering report he provided, they have made numerous improvements throughout the entire building, but there are 3 items that need to be finished before it can be identified as no longer condemnable. A motion to give Mr. Guidry 30 days, with an update at the 7/1/2024 meeting, as presented, was made by Council Member Toups; seconded by Council Member Plaisance. A roll call vote took place as follows: YEAS: Cheramie, Toups, Plaisance, Latiolais, Billiot; NAYS: NONE; ABSTAINED: NONE; ABSENT: NONE.
- Town Attorney Jarreau discussed the possibility of Tamplain Lane being turned back over to the Town with the Mayor and Council. ROW Documents have been drafted and waiting on GIS for plat and property description. Town Attorney Jarreau stated that all of the property owners are not willing to pay for GIS to complete the surveys. She advised the property owner that they have been speaking with, that she would advise the Council to remove this from the agenda and that it can be added back later. She advised it could be put as a condition for someone that buys that property-that they would be responsible for paying for their portion of the surveying. A motion to remove Tamplain Lane being turned back over to the Town from the agenda, as presented, was made by Council Member Toups, seconded by Council Member Billiot. A roll call vote took place as follows: YEAS: Cheramie, Toups, Plaisance, Latiolais, Billiot; NAYS: NONE; ABSTAINED: NONE; ABSENT: NONE.
- A motion to approve the Ordinance to rename Circle G near Ridgewood Blvd to Avenue Vu, as

- 1009 North Bayou Drive-On 5/20/2024, the Council requested SCPDC to inspect the home and contact DFS. Ms. Brandy Alonzo the homeowner is present. She advised that her children are staying with family. Ms. Alonzo has the permit and inspection report and Restore Louisiana is providing an award grant to get her house fixed. SCPDC's Building Inspector Cehan's Inspection report recommends that the dwelling be condemned as it is a harbor for pests, is in danger of possible further collapse, and the electrical inspection failed for multiple electrical inspections. Town Attorney Jarreau recommends that we set a Condemnation Hearing for 7/1/2024 so we

can properly notice Ms. Alonzo and have Restore Louisiana fix her property up to code faster. A motion to accept the Attorney's recommendation, as presented, was made by Council Member Billiot; seconded by Council Member Toups. A roll call vote took place as follows: YEAS: Cheramie, Toups, Plaisance, Latiolais, Billiot; NAYS: NONE; ABSTAINED: NONE; ABSENT: NONE. A motion to have Ms. Alonzo board up any open windows or doors within 1 week, as presented, was made by Council Member Toups; seconded by Council Member Plaisance. Mayor Bouziga advised the Council that we received \$11,042.76, so \$195,345.07 is remaining of the \$205,407.00 for the Lafourche Parish Hurricane Ida Recovery Grant. The deadline is 6/30/2024.

Mayor Bouziga advised the Council that the Parish will request bids in the 2nd or 3rd quarter of 2024 to repair the asphalt on Ridgewood Boulevard, Doucet Drive, and Norman Street.

Mayor Bouziga advised the Council that the LGAP application was submitted on 11/13/2023 and the results are expected July/August 2024.

Mayor Bouziga advised that SBL Construction began cutting the trees behind the DMV this past weekend.

South Central Planning and Development Commission's (SCPDC) Tom Watkins presented the updates on the Condemnation Proceedings:

- <u>BC 1029</u>-Corner of South Bayou Drive-AMC Liftboats-On 5/20/2024, previous demolition bid was rescinded due to it being for the whole building instead of just the front part. The Council requested to send out for demolition bids for the front of the building, which are due 6/17/2024.
- <u>BC 1030</u>-127 Tamplain Lane-Alan and Polly Cheramie-Condemnation Order issued for 30 days. SCPDC's Building Inspector Cehan advised that work is continuing on the house. A motion to give them 30 days, with an update at the 7/1/2024 meeting, as presented, was made by Council Member Toups; seconded by Council Member Cheramie. They have done a little work and his contractor John Picciola has ordered most of the materials and supplies needed to begin a rehab of the property and will be starting on it soon. Mayor Bouziga asked him to keep us updated. SCPDC will inspect the property on 6/17/2024 around 2:30 PM so Mr. Fondren will try to have either Mr. Thomassie or Mr. Picciola or both of them come to the inspection.

On 5/6/2024, the demolition bid was awarded to Harris Construction of LA, LLC for \$2,500.00-awaiting contract execution and notice to owner. Mr. St. Pierre appeared at the 5/20/2024 meeting and advised that the building was being moved, so Council gave 30 days to have it moved. Mr. St. Pierre is present tonight and advised that the organization he donated it to left debris trash on the side of the road. Ms. Janet Rhodus, who was taking the building, stated that their contractor advised them that the building was in too bad of a condition to be moved. Ms. Rhodus and her crew dismantled the building, cleaned up the lot and put the trash in bags on the side of the road. Council Member Cheramie stated that Republic may pick up the trash or they may not. Council Member Billiot advised Mr. St. Pierre that if Republic doesn't pick it up, that he would be responsible to pick it up.
- <u>BC 1048</u>-166 Jefferson Street-Kajun M Investments (Agent-Angie Matherne)-Condemnation Order issued 5/20/2024 and Council requested to send out for demolition bids, which are due 6/17/2024.

A roll call vote took place as follows: YEAS: Cheramie, Plaisance, Toups, Latiolais, Billiot. NAYS: NONE; ABSTAINED: NONE; ABSENT: NONE.

His neighbor stated that he halfway fixed his house and now hurricane season is upon us. A motion to send Mr. Lincoln Martin Jr. a letter to clean up his property and secure any debris, as presented, was made by Council Member Cheramie; seconded by Council Member Billiot. A roll call vote took place as follows: YEAS: Cheramie, Toups, Plaisance, Latiolais, Billiot; NAYS: NONE; ABSTAINED: NONE; ABSENT: NONE.

Mayor Bouziga asked for audience comments.

Ms. Janet Rhodus of Pawsitive Enforcement Project presented Mayor Bouziga with a 2024 LA Boulettes & Balloons Festival Poster and thanked him and the Council for use of the park.

With no further business to discuss, a motion to adjourn this meeting at 8:18 PM, as presented, was made by Council Member Toups; seconded by Council Member Cheramie. The Council unanimously approved the motion as presented.
