- North Sewer Treatment Plant Upgrades-Town Engineer Plaisance advised that they met with
 the Contractor last week to discuss the punch list and he was ok with everything on the list. A
 motion to authorize Mayor Bouziga to sign the Certificate of Substantial Completion for June
 27, 2024, as presented, was made by Council Member Cheramie; seconded by Council Member
 Plaisance. A roll call vote took place as follows: YEAS: Cheramie, Plaisance, Toups, Latiolais,
 Billiot; NAYS: NONE; ABSTAINED: NONE; ABSENT: NONE.
- Sewer Phase VII LCDBG (Terrebonne & Delgrandile)-On 6/3/2024, the Notice to Proceed was issued; contract time is 180 days estimated to be end of 4th quarter of 2024. Work was started today on 8/5/2024.
- Mitigation Project (Seawall)-GOHSEP and FEMA did not approve; looking for other funding services. On 4/15/2024, authorized GIS to apply for the Delta Regional Authority Grant; working with Scalise, Cassidy, and Kennedy's offices on FY25 Appropriations Community Funding Request.
- Infrastructure Grant applications (FMA) (4 main drainage projects)-1 bid received and awaiting GOHSEP approval to proceed.
- Clean Water State Revolving Fund (Sewer Phase VIII (8)) (Cheramie)-Requesting servitude signatures.
- Capital Outlay-Replacement of Sewer Lift Station behind Williams Road-Pre-Construction Conference held on 7/31/2024 and the Contractor is providing submittals for the various equipment and other pieces.
- Capital Outlay-Armand/Alcide Area Drainage-Planning and Construction; Town Engineer Plaisance has drawings to provide.
- Town Engineer Plaisance advised that 9 Capital Outlay requests for fiscal year 24-25 were submitted on 10/31/2024 for projects (Dursette-Pershing Drainage, Jefferson Street Drainage, Oakridge Park Drainage, Maintenance Building 30x80 Lean To (to replace Equipment Shed), Martinez Drainage and Culvert Cleaning Proposal with Atakapa Services), but no new projects were funded by the state, so we will be resubmitting for these 9 projects plus 1 more on 11/1/2024 for next year's requests.
- Chlorine Contact Chamber at the South Plant will need to be replaced-awaiting quotes from STAT, C&A Treatment Services, and a few other companies to replace chamber.

Town Attorney Bryce Autin presented the Attorney's Report:

- Off Road Vehicle Permits-Council to review revised statute and introduce revisions to the Town Ordinance to comply with LA revised statutes. A motion to authorize Town Attorney Autin to work with State Representative Joseph Orgeron to keep revising the statute where golf carts are able to ride on the shoulder of LA1, as presented, was made by Council Member Cheramie; seconded by Council Member Plaisance. A roll call vote took place as follows: YEAS: Cheramie, Plaisance, Toups, Latiolais, Billiot; NAYS: NONE; ABSTAINED: NONE; ABSENT: NONE.
- A motion to authorize Mayor Bouziga to sign the Cooperative Endeavor Agreement with the GLPC for the yearly placement of promotional signs/billboards, as presented, was made by Council Member Latiolais; seconded by Council Member Cheramie. - A motion to authorize Mayor Bouziga to issue/sign a Letter of Intent to purchase a new police vehicle for Budget Year 2024 due to a deadline to order a vehicle of 10/31/2024, as presented, was made by Council Member Billiot; seconded by Council Member Toups. - A motion to hire Post-Certified Police Officer Tyree Smith, who passed his psychological exam, at \$17.50/hour, with a probation period of a year, after which his pay would then increase to \$19.00/hour, as presented, was made by Council Member Toups; seconded by Council Member Cheramie. This motion comes with the stipulation that the town pays whatever he owes to Terrebonne Parish Sheriff's Office (examples: Academy, Bulletproof Vest, Psychological Testing, etc.) not to exceed \$2,000.00. - Update on LPSO Assistance-Chief Dufrene has been talking to LPSO and the Sherriff and they

Mayor Bouziga advised the Council that the Lafourche Parish Hurricane Ida Recovery Grant's (\$205,507.00) deadline is 6/30/2025.

Mayor Bouziga advised the Council that the Parish will request bids in the 2nd or 3rd quarter of 2024 to repair the asphalt on Ridgewood Boulevard, Doucet Drive, and Norman Street. Mayor Bouziga will contact Lafourche Parish President Archie Chaisson for an update.

Mayor Bouziga advised the Council that the LGAP application was submitted on 11/13/2023 and the results are expected July/August 2024.

Mayor Bouziga advised that the debris letter was sent to the Estate for 115 Mrs. Thomas Pitre Lane on 6/25/2024. On 7/15/2024, the SCPDC inspection passed. As of today, the property is still full of debris. A motion to go out for bids for debris clean-up, as presented, was made by Council Member Latiolais; seconded by Council Member Plaisance. State Representative Orgeron advised that the Golden Meadow Bridge is about 80% fixed.

Buffy Charpentier reminded everyone that school was starting on 8/7/2024.

State Representative Orgeron added that the Local Community Block Grant is \$100,000.00 to be split between Town of Golden Meadow, Town of Lockport, and the rest of the Parish. The towns should each receive \$36,000.00, with the rest going to the Parish.

Town Citizen Brian Eymard stated that the traffic is moving much better at the Galliano Bridge with the new flashing lights.

Zachary Gisclair stated he was running for Port Commission Seat F and he would help out the town and citizens any way he can.

Town Citizen Patricia Louviere thanked the Council for trying to get speed bumps, but the cars are still passing too fast down the street.
